DIABETES-RELATED CHRONIC KIDNEY DISEASE ECHO OVERVIEW

- **Program Goal**

- Address the urgent and persistent needs of vulnerable populations of people with diabetes complicated by CKD.
- Engage clinicians in the primary care setting by empowering and increasing the capacity of primary care clinicians (PCCs) to screen, diagnose, and manage renal complications of diabetes

- **When, Where, What?**

- **8 sessions:** October 13, 2022 – January 26, 2023
- Sessions run **twice per month on Thursdays from 7:30 AM – 8:30 AM**
- Convenient virtual sessions **via Zoom**
- Each Session consists of a **brief educational didactic with Q&A** followed by a group discussion on de-identified **patient scenarios submitted by participants**
- **Free Registration and incentives may be earned**

BENEFITS OF PARTICIPATION

- Join a welcoming **learning community** with diabetes and renal experts
- Obtain **clinical tools** (i.e. GFR calculators, patient identification assessment) to improve CKD screening in your practice
- Receive recommendations on **complex CKD patient care**
- Connect your practice and patients with **community resources** to manage Diabetes and CKD
- Learn current **medication management best practices** for Diabetes and Chronic Kidney Disease

WHAT TO EXPECT

- **Each participating practice site identifies key providers to attend ECHO sessions**
 - 2-3 providers from each practice must attend at least 6 of 8 ECHO sessions
 - Each practice site submits a clinical patient scenario for discussion on the ECHO
- **Practice Site & Individual providers participate in our evaluation program**
 - Practice completes initial intake survey to collect Practice/Patient demographics including common HEDIS/NCQA Metrics from the past 12 months (QA representative)
 - Attending providers complete individual pre/post assessments
 - Optional post-series interviews for participating providers to share their ECHO experience
- **Incentives**
 - **\$2,000 Stipend** available to practice sites
 - Must complete all requested evaluations/data collection
 - At least 1 provider from the site attending at least 6 of 8 sessions
 - Free Continuing Education Credits available to participating providers (CME, CNE, CPE & Social Work)
